I understand that reasonable measures will be taken to safeguard the health and safety of all volunteers and participants, and that parents of minor children will be notified as soon as possible in case of any emergency. If an emergency were to happen, I understand that I will be taken to the nearest hospital. In the event that a parent of a minor child cannot be reached in an emergency, I hereby authorize the calling of a physician at my expense to provide whatever medical or surgical treatment is necessary.

It is expressly understood and agreed that Servant Community, Ken or Sue Rheingans (owners of Raspberry Hill Farm-camp event location), Harnischfeger Park (festival location), or any other participating individual or organization, shall not be responsible or legally liable for any losses of personal property or for any bodily injuries, or the results thereof, incurred and suffered by myself, or my child, in connection with any activities or programs taking place that week.

Christian Disciple Farm & Festival 2018 Covenant

Each registered participant will be expected to read carefully and sign.

As a representative of Christ, I, the participant in The Christian Disciple Farm &/or Festival, take seriously my responsibility to care for others. This covenant represents affirmation of my concern for the well being of the total community. I covenant to ensure the safety of all, to make our time together most meaningful, and to care for the facility that we share. In addition I specifically agree and understand that:

† Anything considered illegal in Wisconsin is illegal for everyone participating in The Christian Disciple Farm & Festival.

† I will not partake in tobacco use; drug use; alcohol consumption; possession of firearms, weapons, or fireworks. Tobacco use is discouraged for adults, but is allowed in designated areas. Adults are expected to abide by all other restrictions placed on minors.

† For the safety and enjoyment of the campers, I will not use my cell phone for talking or texting during camp hours at the Christian Disciple Farm. I realize that doing so, may result in having my cell phone taken until camp is over that day.

† I understand that the dress code for all participants is to wear crew neck t-shirts and that clothing should be appropriate for a co-ed Christian environment. Wear clothing that you would be comfortable wearing at your church for a picnic, having lunch with your grandma, or meeting your significant other's parents. For girls, that means no spaghetti straps or strapless tops, no bare midriffs, no cleavage and no short shorts or skirts (use the fingertip rule). Please don't even pack such clothing, as you will be asked to change or given a t-shirt to put on over your outfit.

† I will make every attempt possible to attend training on Sunday night at the Harnischfeger Park. If I cannot attend I will review the materials prior to Monday morning.

† I understand that no one under 18 is allowed off site at the Farm or the Festival grounds without an official adult chaperone.

† I will use language, behavior and attitude which is consistent with the Christian Faith

† I will respect the person, equipment and property of others. (Keep this in mind when considering practical jokes, water fights, etc.) I will do no harm to others and respect the Farm & Festival sites and their property.

† I understand that the Christian Disciple Farm accepts campers based upon the number of volunteers who sign up. I will do my very best to keep my commitment to attend realizing that campers are depending on me.

† Any accidental damage to the Harnischfeger Park or Disciple Farm property will be billed to the persons who caused the damage. Any intentional damage (such as vandalism) will result in expulsion from the event.

† Quiet time begins at 11:00 PM in the tent area, 10PM in RV area and continues until 6 AM the following morning. Curfew is at Midnight. All disciple Festival overnight participants are expected to be in the camping area after curfew.

† It is preferred that electronic entertainment not be used at the Festival. Electronic devices are to be played only during free time and not during quiet time. All noise will be kept at a level that does not disturb others. Violators of this rule may have their equipment taken.

† Visitation between males and females under 18 years old, in tents, RVs, cars, or pop-up trailers is prohibited unless directly supervised in a group setting by the group's official chaperone.

I understand that violations of this covenant and/or other inappropriate behavior could require disciplinary action, for youth and adults. Decisions about appropriate disciplinary action will be made in consultation with the adult group leaders or responsible individual and the Farm and Festival directors. Disciple Farm & Festival directors reserve the right to call parents/guardians or to dismiss any person who breaks this covenant.
